#### *An Ideal Solution – When do I need to rent from Premier?*

##### ❖ **A Solution for Off Site Maintenance**

Like all fall protection equipment, self-retracting lifelines (SRLs) need to be recertified and inspected to maintain compliance and ensure a safe working environment.

Component fractures, stressed cables and deformities can occur during day to day operations of any fall protection system. When possible, Premier addresses abnormalities on site but it is sometimes necessary to inspect or repair SRLs offsite. Premier's Rental Program allows you to rent a temporary unit to ensure no lost time due to equipment repairs.

- Prevents lost production while your unit is off site.
- Ensures your fall protection plan remains in place.
- Reduces employee exposure to fall hazards.

##### ❖ **Temporary Solutions for Short Term Projects**

If you need fall protection for a short term project, Premier's Rental Program allows you to rent on a monthly basis.

- Rental cost helps keep project within budget.
- Single job or temporary solution.
- Allows you to spread the costs over the length of a job.
- Eliminates storage expenses.

## Rental Equipment Guidelines:

The customer is responsible for the following:

1. Providing the knowledge and skills necessary to perform the fields work.
2. Making employees aware of the purpose and limitations of the safety equipment.
3. Ensuring the proper interpretation of equipment measures and fall distance.

- **Employee Training Considerations**

Thorough employee training in the selection and use of personal fall arrest systems is imperative. Employees must be trained in the safe use of the system. This should include the following: application limits; proper anchoring and tie-off techniques; estimation of free fall distance, including determination of deceleration distance, and total fall distance to prevent striking lower levels; methods of use; and inspection and storage of the system. Careless or improper use of the equipment can result in serious injury or death. Employers and employees should become familiar with all applicable OSHA regulations, as well as manufacturer's recommendations, BEFORE a system is used. Certain tie-offs (such as using knots, tying around sharp edges, etc.), can result in dangerously unsafe reductions in strength. Employers and employees must be familiar with, and comply with, maximum permitted free fall distances. The importance of inspections prior to use, the limitations of the equipment and unique conditions at the worksite are of critical importance. Any questions should be addressed to Premier.

**It is essential that the user comply with all recommendations specific to each part associated with the product, as specified in the manual included with shipment.**

Each SRL is limited to one person only, with a maximum total combined weight of 310 lbs. including tools and equipment. The maximum arrest distance of the SRL is 55" inches.

Free fall distance should be kept to a minimum, and as required by OSHA, in no case shall exceed 6 feet. The tie-off attachment point to the lifeline or anchor should be located at or above the connection point of the fall arrest equipment on the harness.

## Equipment Shipment & Return

All rental orders are shipped by UPS delivery unless otherwise specified. Shipping charges will be prepaid and added to the invoice or can be charged using a 3<sup>rd</sup> party shipping account.

Customer is responsible for all return shipment costs. Providing additional insurance coverage is recommended when returning rental equipment, as Premier Fall Protection is not responsible for loss or damages to the equipment while it is in transit.

To avoid any unexpected charges, equipment must be returned with all accessory items.



All costs associated with the return of equipment will be the responsibility of the customer.

The customer is responsible for the safekeeping of all equipment. If it is determined that a piece of equipment has not been properly used or cared for, all additional costs to assure its proper function will be the responsibility of the customer along with any damages due to theft, loss or misuse.

Each piece of equipment shipped from Premier Fall Protection will include an equipment packet that contains the manufacturer’s instruction manual. Equipment breakdowns or malfunctions should be reported to Premier as soon as possible.

## Pricing

Equipment can be rented on a weekly or monthly basis. Rental charges will begin the next business day for ground shipments or shipments scheduled to be received by end of business day. See “Equipment Shipment & Return” for more shipping guidelines. Rental charges stop the day it is returned to Premier Fall Protection
